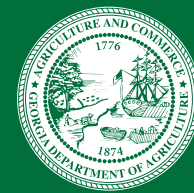

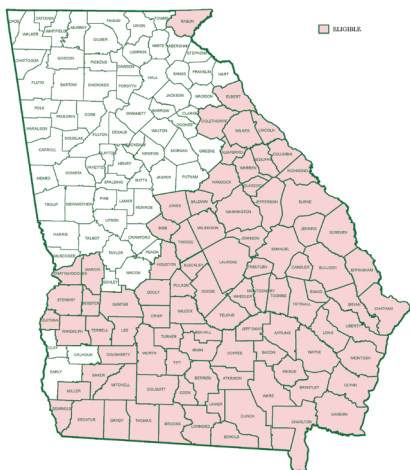

PLASTIC MULCH & BARE-GROUND PRACTICES



- Did you suffer at least a \$1,000 loss?
- Are you applying as an:
 - Individual
 - General Partnership
 - Joint Venture
 - Sole Proprietorship
 - Corporation
 - Limited Partnership
 - Limited Liability Company
 - Revocable/Living Trust
 - Irrevocable Trust
 - Estate
 - Charitable/Tax Exempt Organization

Note: entities are required to list the member names and shares

- What is your name or the name of your operation?
- What is your Tax Identification Number?
- What is your Gate Card Number?
- What is the physical location of the farm? (both)
 - Address
 - Latitude and Longitude
- What is your USDA Farm Number?
- How do you have possession of this farm?
 - Ownership
 - Lease Contract
- How do I prove my interest in the farm suffering a loss?
 - 2024 Tax Assessment
 - Lease Contract
 - Deed

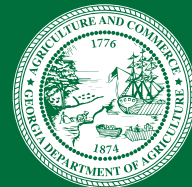
How do I find the Latitude and Longitude of the parcels suffering a loss?

1. Go to google.com/maps
2. On the "Search Google Maps" line, type the address of the disaster affected property OR select the property on the map.
3. Right click on the location of the property
4. An information box will display the latitude and longitude

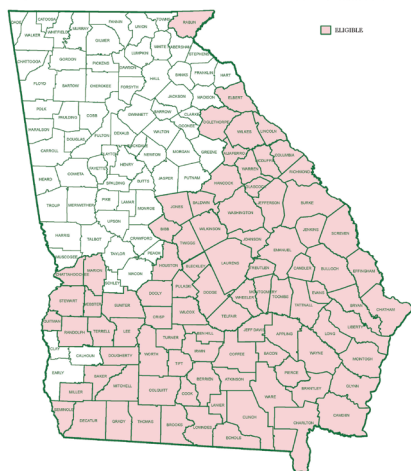

PROOF OF LOSS DOCUMENTATION EXAMPLES

PLASTIC MULCH & BARE-GROUND PRACTICES



- What must I report in order to assess my loss?
 - Number of Plasticulture Acres Damaged by Hurricane Helene
 - Number of Bare Ground Acres Damaged by Hurricane Helene
 - If the fields were used for production within the 12 months prior to Hurricane Helene
- How do I prove damage/destruction loss?
 - Proof of insurance reimbursement
 - Repair bills
 - Replacement invoices
 - Demolition bills
 - Prior and post Hurricane Helene photographs
 - Crop insurance records
 - Acreage reports
 - Other documents you believe will assist in assessing your loss

Documentation listed here is NOT comprehensive.

Applicants may submit additional documentation they believe will support their application.
