TO: All Antifreeze Manufacturers and Distributors

FROM: Doug Killingsworth, Director of Fuel and Measures

RE: Antifreeze Registration/Annual Renewal

Before any antifreeze shall be sold, exposed for sale, or stored, packed, or held with intent to sell in the State of Georgia, the antifreeze brand must be registered with the Georgia Department of Agriculture. Renewal of an antifreeze registration for fiscal years of 2023 (from July 1, 2022, to June 30, 2023) must be completed before June 30, 2022.

To renew a current brand registration (or register a new brand), the following *must* be met:

1. Application(s) must be submitted no later than June 30, 2022, by the manufacturer, packer, or distributor. Several application forms are enclosed. Feel free to make copies of these for your use. Please submit registration of your products electronically and visit <u>https://www.kellysolutions.com/erenewals</u> for instruction. All electronic documents must be in PDF format. If you have any questions regarding the completion of the application, please contact this office.

2. A **formulation certificate** form must be submitted for each product. All relevant boxes must be checked off and all information must be filled out. The name of the product in the formulation certificate must match the name of the product in the label. Each product must have a formulation certificate. Certified, signed test report(s) of the product formulation prepared by an independent laboratory recognized by the Georgia Department of Agriculture are required in accordance with this form's instructions. Georgia legislation requires the addition of denatonium benzoate in antifreeze sold after July 1, 2012 (Chief Law). Please include the exact amount of denatonium benzoate (30- 50 ppm range) in the certified, signed antifreeze test report(s). The antifreeze product label <u>must</u> contain wording such as "Bitterant added", "Contains Bittering Agent" or have denatonium benzoate listed as an ingredient. **3**. License fees of \$50.00 *for each brand or type of antifreeze* and a product label (color label, front & back, as they appear on container).
